I refer to Mr Lovelock's request on 3rd December 2008 for information under the Data Protection and Freedom of Information Acts : e.g. internal and external emails. On 15th December 2008 you replied, saying you would provide the requested information within 40 days allowed by the Act.

You now state in your letter of 28th January 2009 "Mr Saunders has requested that the consent to pass his information directly to yourself be rescinded",

This is untrue. Mr Lovelock is still my Official Representative. I demand to know who told you this, where, when and to whom they claim I made this statement. I never made such a statement. Also, there have only been two recent meetings with Buckinghamshire County Council (BCC) staff. That on 9th January by Jim Peart of Social Services, another person, and the manager of Chiltern Court. This meeting was brief and resulted in a complaint to the hospital. It was against my wishes witnessed at the meeting at Chiltern Court on 5th August 2008, the record of which is public, and where I stated that any future meeting be attended by Nr Lovelock. Mr Peart visited me again, without warning, at Larkland House, on 27th January. This was witnessed by Mr Lovelock and Larkland House staff. I asked Mr Peart to leave and he did so immediately. I had asked, through Mr Lovelock, for Mr Peart to be replaced as my assigned care worker some time ago. e.g. letter TAS9.

I repeat what I've said in signed and witnessed statements TASTAS1 dated 22nd October 2007 and TASTAS2 dated 24 November 2008: I am happy for Robin Lovelock to have full access to all information about me, including detailed medical information, financial information, and any information relating to my case. Robin Lovelock is my official representative, on whom I rely for written communication with the NHS, Buckinghamshire Council, and he acts on my behalf with my solicitors. He has my authority to place information into the Public Domain after consulting with me verbally.

I wish to remain at Larkland House in Berkshire, within the constituency of Adam Afriye, MP and wish Mr Afriye to act on my behalf.

You should be aware that my other solicitors are insisting that the NHS fund Larkland House, in accordance with the National Framework. This must continue until the appeal for Continuing Care process is complete, even if this is after the outcome of a Judicial Review.

I demand that you continue actioning of Mr Lovelocks request for information, dated 3rd December 2008, without further delay. Also, that you begin by providing Mr Lovelock with all records, Internal and external communications that you already hold, such as those between yourself and others. I request that this be delivered to Mr Lovelock no later than Friday 13th February. I suggest that you note the contents of Mr Lovelocks letter to Chris Williams, Chief Executive of BCC, ref TAS10 13th January 2009.

I intend to have this letter witnessed by others, including my solicitors.

Please speak to Robin Lovelock and/or my solicitors on all things. I do not wish to see BCC staff until these matters are resolved.
